### **Pomeroy Names Head of Mergers & Acquisitions**

Quish

also spent several years with Cable & Wireless (C&W) where he led an IBM-Compaq-C&W virtual desktop joint venture and incubated C&W's managed hosting services start-up, Bluefield.com. While at C&W, Quish was instrumental in the acquisition and integration of companies representing more than \$400 million in aggregate annual revenue, including the managed hosting firms Digital Island and Exodus. Quish also managed several C&W business units through divestitures and transitions that proved to realize market leading valuations for C&W and achieved long-term value for purchasers.

"Chris's proven ability to identify and capitalize on early market trends will allow Pomeroy to identify businesses with capabilities and synergies that will exponentially accelerate Pomeroy's managed services growth," said Chris Froman, President and CEO of Pomeroy.
